- 6. Sno-King Conducting Meetings and Business as a "Public Agency":

There was discussion regarding the types and quantity of records that are created by SnoKing, including an index which was created since the last meeting of the files maintained by Cross Valley Water District. There was a discussion as to how the Coalition might maintain email records where a mailbox of one of

the member agencies would be set up in the name of SnoKing, all SnoKing related emails would carbon copy this mailbox regardless of sender or recipient to create a primary record set of SnoKing email. Finally a proposal by Code Publishing was reviewed. Per the proposal Code Publishing would create and host a home page, post the ILA, bylaws, meeting schedule, Meeting minutes and other miscellaneous documents for an initial cost of \$750 with annual online hosting cost of \$350.

A motion approving the proposal by code publishing was approved

A motion approving the development of a policy and practice for SnoKing email records was approved

7. Legislative Report

Steve Lindstrom gave a report on current activity of the Legislature and Governor's office. Including the failure of the Legislature to adopt a budget and the Governor's veto of many bills in response. The group discussed possible outcomes of the special session related to the budget, bills of interest and vetoed bills.

8. SnoKing Membership Criteria

Discussed membership criteria for SnoKing including number of members and criteria as how to evaluate new potential members. At the end of the discussion Jeff Clarke agreed to draft criteria for review at the next meeting that would recommend a total number of members, criteria that members must be a Water or Water/Sewer District organized under title 57, a geographic location consideration, a minimum initial membership term and criteria for general alignment on areas of interest with other members.
