Lobbyist Steve Lindstrom provided updates on various topics.

 ESSB 5033 – Public Works Board. Lindstrom reported he testified on the bill, noting a similar Public Works Assistance Account bill, SHB 1677, was well crafted, well worked, and is a much better bill.

- HB 1594/1595 Public Records. Lindstrom reported there are several bills pertaining to Public Records, noting HB1594 is currently on the house floor and HB1595 is back for reconsideration.
- SB 5119 WASWD's Omnibus Bill. Lindstrom reported that after removing the section relating to disposal of surplus property, the bill is likely to pass and move on.
- SB 5239 Hirst Fix. Lindstrom reported the bill is in house committee.

### 6. OTHER BUSINESS

Lora Petso shared her concern on the regulation of direct injection of storm water and the gaps in permitting them between Department of Health, Ecology and local land use authorities.
